To participate in the tender process bidder must submitted application on printed pad along with Copy of valid PEC license in Category C-4 or above, copy of valid NTN certificate and must be listed on Active Taxpayer List (ATL), copy of valid CNIC, Registration proof with PPRA on E-PADs, Affidavit of Proprietorship, no blacklisting & litigation on Stamp paper of Minimum Rs. 500/-

A set of Bidding Documents containing detailed terms and conditions can be purchased by well reputed bidders from the office of undersigned during office working hour (0900 Hrs. to 1530 Hrs.) against payment of Rs. 3000/- payable in the shape of “Cash / Pay order / Demand Draft” in favor of PAEC Foundation (non-refundable) as tender fee.
