To participate in the tendering process bidder must submitted application on printed pad along with Copy of valid PEC license in Category C-6 or above, copy of valid NTN certificate and must be listed on Active Taxpayer List (ATL), copy of valid CNIC, Affidavit of Proprietorship, no blacklisting & litigation on Stamp paper of Minimum Rs. 200/-
3. A set of Bidding Documents containing detailed terms and conditions can be purchased by bidders from the office of undersigned during office working hour (0900 Hrs. to 1630 Hrs.) against payment of Rs. 3500/- as tender fee payable in the shape of cash. However, issuance of tender documents shall be closed one day prior to the opening date.

Bid Security @ 2% of the quoted amount (refundable) must be submitted in separate envelop in the form of Pay Order / Bank Draft / CDR or Bank Guarantee from any scheduled bank in favor of “**PAEC Foundation**”. **However, if any bidder opts to submit Bank Guarantee, it must have an expiry date of at least 06 months from the date of bid opening.**

The original bidding documents along with bid security in sealed envelope, pre-signed and stamped must reach to the Office of General Manager (Foundation) on above mentioned address before due date and time. The bidder(s) / Firm(s) not submitted the aforementioned documents shall be treated non responsive.
6. Responsive bids will be opened in presence of Tender Opening Committee & bidders authorized representatives who opt to participate, in the office of undersigned on due date and time. Further, the committee reserve the right to demand the analysis of quoted rates to check their reasonability and workability.
7. PAEC Foundation reserves the right to reject any or all the bids / proposals at any time prior to the acceptance of a bid or proposal on the basis of valid reasons as per PPRA Rules.
